**AN ORDINANCE OF THE CITY COUNCIL OF  
THE CITY OF CASTLE PINES NORTH  
AMENDING ORDINANCE NO. 09-10 CONCERNING THE DUTIES OF THE  
TREASURER**

WHEREAS, the Treasurer of the City of Castle Pines North is an elected position and serves as an officer of the City, and pursuant to Section 31-4-107, C.R.S., is subject to the control and supervision of the Mayor; and

WHEREAS, pursuant to Section 31-4-111, C.R.S., the Treasurer has such powers and shall perform such duties as are prescribed by state statutes and by ordinances of the City Council; and

WHEREAS, Article 20, Title 31, Part 3, C.R.S., provides for the duties of the Treasurer, to be performed in such manner as may be prescribed by ordinance; and

WHEREAS, the City Council previously adopted Ordinance No. 09-10 to clarify and define the duties and powers of the Treasurer; and

WHEREAS, the City Council desires to amend Ordinance No. 09-10 to further clarify the duties of the Treasurer specifically as such relate to the oversight of the City's annual audit; and

WHEREAS, the City Council recognizes that the annual audit is a responsibility of the City Council under Section 31-1-606, C.R.S., and that the Treasurer has no statutory responsibility or oversight of such audit.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CITY OF CASTLE PINES NORTH, COLORADO, as follows:

**SECTION 1.** Section 3 of Ordinance No. 09-10 is hereby amended to remove the last sentence such that the provision shall read:

**Annual Report and Audit.** Unless otherwise determined by resolution of the City Council, the City Council shall retain an auditor to prepare the Treasurer's annual financial report and the annual audit of the City's financial statements, each to be prepared in conformance with state law.

**SECTION 2.** Except as amended herein, Ordinance No. 09-10 shall remain in full force and effect.

**SECTION 3. Severability.** If any portion of this Ordinance is found to be void or ineffective, it shall be deemed severed from this Ordinance and the remaining provisions shall remain valid and in full force and effect.

**SECTION 4. Effective Date.** This Ordinance shall become effective thirty days after publication following final passage.
