**A RESOLUTION OF THE CITY COUNCIL FOR THE
CITY OF CASTLE PINES NORTH, COLORADO SETTING LICENSE AND
APPLICATION FEES FOR ALCOHOLIC BEVERAGE LICENSES PURSUANT TO
ORDINANCE NO. 09-01**

WHEREAS, by Ordinance No. 09-01, the City Council established a liquor licensing authority and authorized the authority to accept applications for alcoholic beverage licenses to applicants operating liquor licensed establishments within the City; and

WHEREAS, Ordinance No. 09-01 establishes that new application, renewal and licensing fees shall be set by City Council by resolution; and


WHEREAS, the City Council finds that the fee amounts set forth herein are based on costs to the City for administering a liquor licensing program.


Section 1. The City Council hereby adopts the attached Alcoholic Beverage License Fee Schedule, attached hereto and incorporated herein as **Exhibit A**.


