**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF CASTLE PINES NORTH
ADOPTING THE DOUGLAS COUNTY 2020 TRANSPORTATION PLAN AS
THE CITY'S 2020 TRANSPORTATION PLAN**

WHEREAS, the "DOUGLAS COUNTY 2020 TRANSPORTATION PLAN – AN ELEMENT OF THE DOUGLAS COUNTY 2020 COMPREHENSIVE MASTER PLAN" (the "Transportation Plan") was prepared by the transportation engineering consulting firm of Felsburg Holt & Ullevig for and on behalf of the Douglas County Departments of Public Works and Community Development; and

WHEREAS, a copy of the Transportation Plan is attached hereto as Exhibit A and is incorporated herein by reference; and

WHEREAS, the Transportation Plan emphasizes the need to encourage a multi-modal approach to the overall development of the Douglas County transportation system which include: (a) strategies to expand transit options and bikeway/pedestrian facilities; (b) strategies to incorporate travel demand management techniques into the process of transportation supply expansion; and (c) active pursuit of right-of-way preservation as an important method to insure long term flexibility for new transportation technologies; and

WHEREAS, the main goal of the Transportation Plan is to sufficiently plan for transportation infrastructure that is safe, efficient, and responsible to current and future residents, and visitors of Douglas County; and


WHEREAS, the Transportation Plan has been reviewed by the Community Development Department and the Public Works Department of the City of Castle Pines North, and the departments have recommended that City Council consider formally adopting the Transportation Plan as the City of Castle Pines North 2020 Transportation Plan.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CASTLE PINES NORTH, COLORADO:

Section 1. The City Council of the City of Castle Pines North hereby adopts the Transportation Plan as the City of Castle Pines North 2020 Transportation Plan, in substantially the form attached hereto as Exhibit A.


Section 2. This Resolution shall become effective immediately upon passage and approval.
